## 2016/4397 TO RECEIVE UPDATES/REPORTS

- Police Report/NHW Reports circulated to Councillors and placed on website. We have received an email from David Rischmiller, Rural and Business Crime Co-Ordinator, North Worcestershire Community Safety Partnership introducing himself to the Parish Council. It was agreed for the Clerk to invite him to one of our Parish Council meetings.
- 2. District Councillors -



Cllr. Sherrey - Please accept my apologies for being unable to attend the Parish Council meeting. I have to attend an Overview and Scrutiny Board at District Council this evening. The Council moved into Parkside on 15th December. The reduction of 54% in the Revenue Support Grant for the next financial year from central government was much higher than expected. For 2017/18 onwards payments will be made to the government. This was not expected until 2019/20. The retention of part of the business rates revenue from 2020 will probably not cover the shortfall. We are currently looking at how we can absorb this reduction without affecting front line services. I will also be having a meeting with Greg Clark, Secretary of State for Communities and Local Government, to see whether this can be changed. We are working on attracting more businesses, both large and small, to set up in the District. These will not only be in the town centre area but also throughout the District. A proportion of business rates on new businesses will go direct into our own finances to help offset the drop in Revenue Support Grant.

#### Cllr. Colella

- Government Consultation on New Homes Bonus a 12 week consultation has begun on the New Homes Bonus. A number of changes are being proposed which include, reducing the payment period from 6 years to 4 or even less, no NHB paid where there is no local plan, no NHB paid where application was determined on appeal and NHB only paid where housing delivered above what would have been delivered anyway i.e. 'overspill' from adjoining authorities. As a result Bromsgrove faces a deficit of £2.3m.
- 16/17 Bromsgrove Budget setting and three year financial planning Bromsgrove is entering is 2016/17 budget planning stage and long term financial planning.

  Opposition groups (including the Independent Alliance Group of which I am the Deputy Leader) will be submitting their own alternative budget proposals. Bromsgrove faces a significant higher reduction in its Revenue Support Grant than those across England. Bromsgrove is also only a small number of none 'southern authorities' to face such a high cut. The reason given is because Bromsgrove's high level of property based wealth i.e. Houses above band D level. As a result they face a reduction of £3.2m from 2016/17 across the remaining Parliament.
- Official Council Office move to Parkside, Stourbridge Road. All meetings will now be held at Parkside but please be aware of the limited number of parking spaces.

Clir. Allan-Jones - No report given.



County Cllr. Jenkins – Major cuts in funding from Central Government, council tax increased by 3.9%. 2% Social Services which central government allowing them to increase, 1.9% maximum allowed to increase without going to a referendum. The original government grant is going to be completely reduced to nothing by 2020 and believe it is 39% decrease this year alone but haven't yet got full budget till February, I will bring the full budget to the next meeting.

- 3. **Community Governance Review –** Agreement has been reached between Bromsgrove District Council, Hagley Parish Council and Clent Parish Council. We are now awaiting the completed Section 99 Agreement and the transfer will commence from 1<sup>st</sup> April 2016.
- 4. **Bus Shelter** this project has been put on hold.
- 5. **Queen's 90<sup>th</sup> Birthday** this has been discussed under Youth Council.
