2016/4519 GRASS CUTTING/HEDGE MANAGEMENT/CENTENARY FIELD/PLAY AREAS

Hedges around the parish are due to start being cut back in October/November. Clerk was asked to instruct Steve to cut the triangle of grass outside Sunfield.

It was unanimously agreed to apply for planning permission to install community toilets adjacent to the cricket pavilion, this will enable the cricket pitch to be used by local community groups/residents and the local primary school. Cllr. Sheppard is to liaise with local architect John Price and submit the plans to Bromsgrove District Council. He is also going to submit an application to Western Power for an electricity supply to the cricket pavilion.

The boules pitch is starting to get some usage, it was agreed to order a couple of sets of boules. The opening ceremony is to be delayed until next summer when the toilets are installed. It was felt a sign/noticeboard detailing the rules for the boules pitch would be a good idea and Clerk is to try and source some ideas/quotations.
