When you contact us:

The information you provide (personal information such as name, address, email address, phone number, organisation) will be processed and securely stored to enable us to contact you and respond to your correspondence, provide information and/or access our facilities and services. Your personal information will not be shared or provided to any third party.

The Council's Right to Process Information:

Information Security

Clent Parish Council has a duty to ensure the security of personal data. We make sure your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures, such as password protection and physical security, and adherence to our Data Protection Policy. Copies of all the council's policies can be seen on our website upon application.

We will only keep your data for the purpose it was collected for and only for as long as is necessary after which it will be deleted. You may request the deletion of your data held by Clent Parish Council at any time.

Children

We will not knowingly process any data relating to a child (aged under 13) without the express parental/guardian consent of the child concerned.

Access to Information

Information Correct
