Members of the public raised the following issues:

District Councillor Margaret Sherrey provided updates on the following:

• BDC vehicles are to be converted to be able to run on refined vegetable oil instead of diesel.

County Councillor Karen May provided updates on the following:

- There are multiple vacancies at both BDC and WCC particularly in finance due to a number of staff taking up roles in the private sector.
- Integrated Care System
- WCC council tax rise of 3.94%, 3% of which is directly related to adult social care.
- Clent Connect thanks to the PC for their support to the project.
- New Highways Liaison Engineer is now in post.
- Lights on the roundabout are now on following WPD cutting through cabling.
- Funding received for flood and water management surveys.

5340 Minutes

5341 Clent Connect Update

5342 Queen's Jubilee Celebrations

Cllr Sheppard reported that he now has the beacon socket ready for installation on Centenary Field.

5343 Finance

- (a) It was **RESOLVED** to pay the following for March 2022:

 - (iii) Bromsgrove DC Lease of Land £60.00
 - (iv) Clent Parish Hall Hall Hire £55.00
 - (v) Clent Connect (Hub Grant 1st payment) £1500.00
 - (vi) Nick Sugden Chairman's Allowance £500.00
 - (vii) Steve Bubb (field maintenance 21/22) £1000.00
- (b) It was **RESOLVED** to approve the budget monitoring report dated 28/02/2022 prepared by the Clerk.
- (c) It was **RESOLVED** to approve the February 2022 bank reconciliation noting a balance of £96,587.98 as at 28/02/22.

5344 General Maintenance and Highway Matters

- (a) Grit bins on Adams Hill and Kings Meadow Cllr May is meeting with the NT soon and will agree a location for the bin. Cllr Sheppard has the bin for Kings Meadow and will liaise with the resident about its location. The PC would fill the bin (funding from Cllr May).
- (b) Village Pond Cllr May had received confirmation from WCC that the silt trap has been cleared out. Cllr Sheppard is still obtaining quotes for the tree work.
- (c) Walton Pool Hedge Cutting Cllr Sheppard has inspected this and the encroachment onto the highway is very minor and he will deal with this in due course.
- (d) Lengthsman Scheme it was **RESOLVED** to agree to sign up to the scheme for 2022/23 with an increased grant of £2895.53 from WCC. The Clerk would sign the agreement.
- (e) TRO on Hagley Wood Lane It was **RESOLVED** to provide a positive response to a consultation from WCC to make the No Waiting restriction permanent on Hagley Wood Lane.
- (f) Village entry flower boxes It was **RESOLVED** to spend up to £250 to plant up the village entry flower boxes.
- (g) Western Road speed limit Cllr May is meeting has a meeting on the 31st March with the police and council officers in relation to the extension of the 30mph speed limit on Western Rd and will provide an update at the next PC meeting.
- (h) Pot holes on Adams Hill These have been reported and Cllr Andrew Sherrey would send details to Cllr May.

5345 Field Maintenance and Play Areas

- (a) Lease on Trim Trail awaiting information/decision from BDC.
- (b) Boggy area behind goalposts Cllr Sheppard would barrier off the area. The pipework needs investigating which would be a WCC responsibility. The Clerk would send information to Cllr May.

- (c) Replacement picnic table The table has been put together but it may need a slab surface. Cllr Sheppard would investigate this.
- (d) Gate from field onto Hossil Lane has dropped and is difficult to open Cllr Sheppard would look at this.

5346 Additional Defibrillators

The defib cabinets have not yet arrived so the Clerk would chase the supplier again. The telephone box on Adams Hill still belongs to WMP so the unit cannot be installed until it is formally offered to the PC.
