Minutes

5399 Apologies for absence

5400 Declarations of interest

Cllr Ed Sheppard declared a Pecuniary Interest in Minute 5404(b)(v, vi) as he is the parish Lengthsman. Cllr Sheppard did not vote on this item or sign the cheque.

Open session

The meeting was adjourned for the open session and the following reports/updates were noted.

Public comments/questions:

The following issues were raised by members of the public:

- Potholes in Hossil Lane resident advised to report to WCC online.
- Spring into pond needs maintenance. Cllr Sheppard will deal.
- Strimming on Holy Cross Green. Cllr Sheppard will deal.
- Parking on yellow lines around the Bell & Cross. The Clerk would follow up with Cllrs May and Margaret Sherrey as to ongoing enforcement.
- Hedge around cricket pitch needs cutting. Hedge cutting will begin imminently.
- Pond maintenance and island trees. Work on trees will begin once the new lease on the trim trail field has been agreed with BDC.
- Tree overhang outside 10 Church Ave this had been inspected by Highways and action agreed, but the problem persists. The Clerk would follow up with Cllr May.
- State of pavements outside the Bell & Cross the resident was advised to report to WCC online.
- Light is still out on Bromsgrove Road. The Clerk would follow up with Cllr May.

 National Trust – an update was provided by George in relation to the work on improving the Nimmings car park area to deter night-time ASB. George will also follow up on potholes in Adams Hill car park and the use of recyclable cups in the café.

- (e) It was **RESOLVED** to ratify the details of the council's insurance policy for 2022/2023 as agreed by e-mail.

5405 General maintenance & highway matters

- (a) It was agreed that the Clerk would write to the landowner whose hedge is overgrowing onto Holy Cross Green to request that it is cut away from the highway. The details will be on the planning application 22/01242/FUL.
- (b) A tree branch on Sunfield land by the Fountain Inn had recently fallen onto the road. The Clerk would write to Sunfield to report the issue.
- (c) Speeding on Church Avenue. This had been raised previously and Cllr May had said that she would arrange for a speed survey to take place. The Clerk would follow this up with Cllr May.

5406 Field Maintenance & Play Areas

- (a) Trim Trail land lease this is still outstanding from BDC and the Clerk would ask Cllr Margaret Sherrey to follow up on this.
- (b) The new picnic table would be placed where the old trampoline was, and Cllr Sheppard will install this in the next few weeks.
- (c) It was **RESOLVED** to withdraw the dog waste bag service as it was being abused and did not seem to reduce dog fouling on the fields. The existing stock would be used up first and appropriate signage will be installed to advise field users and pointing out where the bins are.
