Minutes

5454 Apologies for absence

5455 Declarations of interest

Open session

The meeting was adjourned for the open session and the following reports/updates were noted.

Public comments/questions:

The following issues were raised by the public:

- Plastic barriers belonging to Ringway are still in the park following work on the pipes.
- Tree planting on pond island. It was clarified by the Vice Chairman that following the clearance of the willow etc there would not be any more planting on the island.
- Flooding/drainage problem on Hossil Lane is still as bad as ever. Cllr May would follow up on this with officers at WCC.
- Hedge cutting debris has been left on the footpath alongside the pond. Cllr Sheppard would deal with this.
- Surfacing of path alongside pond. This was ongoing.
- Parking issues on Hagley Wood Lane yellow lines need to be extended by 1 car length towards the car park. Cllr May would take this up.
- Parking issues around the Bell and Cross. BDC have issued tickets but Cllr May would ask for more enforcement.

- Nimmings car park entrance and anti social behaviour particularly at night. The NT are working with the police to try and stop the dealing of drugs on the premises at night.

- (b) It was **RESOLVED** to approve the budget monitoring report dated 28/02/23 prepared by the Clerk.
- (c) It was **RESOLVED** to approve the February 2023 bank reconciliation noting a balance of £97,463.71 as at 28/02/2023.

5460 General maintenance & highway matters

(a) Street lamp 3 outside the village hall is now lit.

(b) Inconsiderate parking around the Bell and Cross Public House – a consultation by WCC to install further parking restrictions is due to be carried out.

5461 Field Maintenance & Play Areas

- (a) Replacement of trampoline in play area ideas welcome. Needs to be something more robust than the trampoline. Zip wire was mentioned by a resident.
- (b) Pathway beside the pond quote is being obtained from the company who did the work on the drainage in/around the pond.
- (c) Fencing around Boules pitch. The fence around the Boules pitch needs to be replaced. It was **RESOLVED** that Cllr Sheppard would carry out this work at a cost of up to £700 (ex VAT).

5462 Planning

- (a) 23/00300/FUL Proposed new dwelling 1 Kings Meadow, Holy Cross. It was **RESOLVED** to raise no objection.
- (b) Application for Technical Details Consent for the erection of detached self-build, live/work dwelling following approval of Permission in Principle (ref. 21/00017/PIP. The Parish Council passed on concerns raised by parishioners living nearby who had issues over increased traffic flows from running a business in a narrow lane. There were also concerns that the traffic survey carried out by the applicant had been done in the middle of lockdown and was therefore not a true reflection of normal flows. The PC were not objecting to the application.
