(a) It was **RESOLVED** to approve the payment of the following for April 2023:

- (b) It was **RESOLVED** to approve the budget monitoring report dated 31/03/23 prepared by the Clerk.
- (c) It was **RESOLVED** to approve the March 2023 bank reconciliation noting a balance of £92,228.75 as at 31/03/2023.

5471 General maintenance & highway matters

- (a) It was **RESOLVED** to continue with the County Highways Lengthsman Scheme with an increased grant from WCC of £3040.31, and retain Ed Sheppard as the parish Lengthsman at a rate of £14 per hour.
- (b) Blue phone box on Adam's Hill this is due to be transferred to the PC to house the new defibrillator but there had been no further communication from WMP. Cllr Andrew Sherrey would chase this up with Hindlip.
- (c) Replacement VAS for Belbroughton Road. The Clerk had confirmed the location with the WCC Liaison Officer and the type of sign that is required, and a site survey would be carried out. This was several weeks ago, so Cllr May would follow up on this.

5472 Field Maintenance & Play Areas

- (a) Replacement for the trampoline in the play area the Clerk would put together a list of supplier websites for councillors to browse and make a list of ideas.
- (b) Fence around the pond. A request had been made from a resident that a fence should be erected around the pond. Councillors were not generally in favour of this preferring a life saving ring as an alternative. The Clerk would make enquiries with the council's insurers.
- (c) Trim Trail. Much of the wooden equipment needs to be replaced/repaired following the RoSPA safety inspection, although there were not any immediate safety concerns identified. Quotes would need to be obtained and using recycled plastic would be investigated.

5473 Planning

(a) 23/00407/FUL - Replacement single storey extension following demolition of existing, including alterations to the patio area - St Elizabeth Cottage, Woodman Lane. It was **RESOLVED** to raise no objection.
