- (b) It was **RESOLVED** to approve the budget monitoring report dated 30/09/24 prepared by the Clerk.
- (c) It was **RESOLVED** to approve the September 2024 bank reconciliation noting a balance of £78,259.21 as at 30/09/2024.
- (d) It was **RESOLVED** to accept the external auditor's report on the 2023/2024 accounts with no issues identified.

5671 General maintenance & highway matters

- (a) WMP Phone box on Adams Hill. An electrician needs to be arranged to look at installing the defib in the box as it needs an earth rod. Cllr Sheppard will liaise with an appropriate electrician.
- (b) Odnall Lane pavement, hedges and "dangerous" wall. The NT had not arranged for any work to the wall, but the NT confirmed that their side of the wall is not subsiding and does not need any intervention.
- (c) Nimmings Car Park and highway improvements to discourage late night ASB. The NT are committed to moving the entrance gateway towards the junction but WCC are blocking the work. Cllr May and the NT are continuing to work on this.
- (d) Bench outside the church needs new slats. Costs were being investigated by Cllr Sheppard.
- (e) Holy Cross Green installation of steps up to the bench. Costs were being investigated by Cllr Sheppard.

(f) Cllr A Sherrey reported a large pothole has opened up again following a recent patch. The Clerk would report this to WCC.

5672 Field Maintenance & Play Areas

- (a) Trim Trail removal/replacement this was ongoing with Cllrs Sheppard and Mudie.
- (b) Trim Trail land extension of lease to allow for investment by the PC this was ongoing with Cllr May and BDC.
- (c) Pond footpath levelling/surfacing the Chairman would ask the tree contractor to quote for this work as the general contractor had not responded.
- (d) New backboard for basketball hoop. Cllr Sheppard would provide a photo to the Clerk so that the play company that installed the latest set of play equipment could provide a quote.

5673 Planning

- (a) New applications (a) 24/00893/FUL Extension to detached garage/workshop building Vine Cottage, Vine Lane. It was **RESOLVED** to raise no objection.
- (b) Kings Meadow an address in Kings Meadow which recently had permission granted for an extension seemed to have some very large footings dug. Cllr ffoulkes would monitor the progress of the work and report to planning enforcement if necessary.
