5758 Minutes

It was **RESOLVED** that the minutes of the Parish Council Meeting held on 19th May 2025 be agreed as a true record of the proceedings and signed by the Chairman. ***NOTE – there was no meeting in June***

5759 Correspondence

The following correspondence was considered:

- (a) From WMP asking for any updates on the PC's crime and policing priorities. It was agreed that the priorities remained the same anti-social behaviour on Clent Hills, speeding on Church Avenue in particular and flytipping.
- (b) From a resident reporting that the VAS on Bromsgrove Rd is not working. See Minute 5761 below.
- (c) From a resident asking when the gateway planters are going to receive some attention. See Minute 5761 below.
- (d) From WMP asking for the PC to identify any fly tipping "hotspots".

 The "hotspots" were identified as Clent Hills, Nimmings/St Kenelms Pass and Walton Pool Lane.
- (e) From BDC approving the PC's grant application for new play equipment up to £6,250. This was noted. See Minute 5762 below.
- (f) From a resident in relation to "dangerous parking" near the Woodman pub on Bromsgrove Rd. It was agreed that it was too early since the pub re-opened to object, and the parked cards to slow down traffic. The situation would be monitored.

- (c) It was **RESOLVED** approve the budget monitoring report (circulated previously)
- (d) It was **RESOLVED** approve the monthly bank reconciliation for May 2025 and June 2025 (circulated previously) noting a balance at 30/06/2025 of £96,284.46
- (e) It was **RESOLVED** to switch banks to Unity Trust Bank and change to online banking with a three tier authorisation process for payments.

5761 General maintenance & highway matters

- (a) Nimmings Car Park and highway improvements to discourage late night ASB (Cllr May/NT) progress update on stopping up order and new TRO this was with the NT currently.
- (b) Repairs to bench outside church progress update (Cllr Sheppard) this would be completed within the next fortnight,
- (c) Litter bin outside parish hall quote from BDC (Cllr May) this was with Cllr May.
- (d) Odnall Lane pavements are narrowed by overgrowing vegetation. The Lengthsman would be asked to side out the footways.
- (e) Road signs around Violet Lane and Walton Pool Lane need to be checked as some need washing and some are hidden by vegetation. The Lengthsman had already completed work on some signs in that area but would check for any others that need attention.
- (f) New VAS on Bromsgrove Road it was **RESOLVED** to spend £2000 on a new solar powered VAS to replace the battery powered unit on Bromsgrove Road. Cllr May would also contribute £400 from her WCC Divisional Fund, and Cllr May and Cllr Nock would contribute £250 each from their BDC Member funds. Cllr May would arrange for the unit to be ordered and installed.
- (g) Gateway planters it was agreed that the gateway planters needed some attention. Cllr Sheppard had recently weeded them but a plan to plant them up and maintain them was needed. Cllrs ffoulkes and Bates would approach the local gardening club to see if they could assist.

5762 Field Maintenance & Play Areas

- (a) Trim Trail field lease update re potential asset transfer. This is with the BDC legal department.
- (b) Pond footpath levelling/surfacing update on new contractor to carry out work no update.
- (c) New play equipment to be purchased with the BDC Community Grant. It was agreed to purchase an accessible roundabout and different styles and prices would be investigated. There had been a quote from Playdale already for £7195 (unit only). BDC grant would cover 50% of the overall cost.
- (d) Playground 3 year maintenance and replacement plan it was agreed that a 3 year plan should be drawn up to maintain and/or replace the existing play equipment as some of the units are close to the end of their life. Cllrs ffoulkes would start work on this and report back at the next PC meeting. The Clerk would circulate the 2025 RoSPA report to all councillors for information.
- (e) Pathways and gates it was noted that it is all very well having accessible play equipment but the entry points and general surface to and around the play equipment is inadequate. Cllr Bates would look at improving/replacing the gated access to the play area, and the surfacing would be included in the 3 year plan.
- (f) Orchard the trees in the orchard need to be topped. Cllr Sheppard would arrange this.
